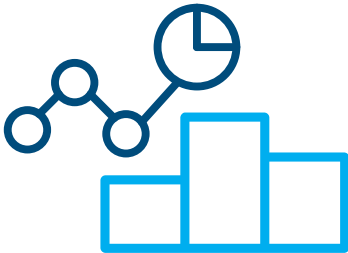

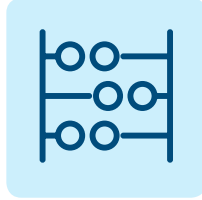

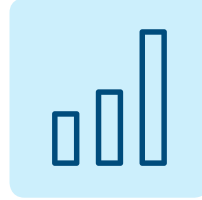

An online database with Spanish legislation, jurisprudence, administrative doctrine and complementary texts in the fiscal, accounting and social areas, systematized by Ediciones Francis Lefebvre based on its Mementos prácticos.

### **Global Arbitration Review**
