GENERAL INFORMATION – ESADE NEED BASED SCHOLARSHIPS

All candidates are eligible to apply for financial aid to assist with their educational expenses. In order to ensure that financial aid from ESADE is available, we encourage candidates to begin the Scholarship Application submission when they apply for Admission.

Our suggestion is to send the Scholarship Application Form during the admission process, therefore all the supporting documents requested by the Admissions Committee (GMAT/GRE, TOEFL, Transcripts, Admissions Essays, interview, etc.). Please note that candidates should have submitted all required documentation in order to be evaluated by the Scholarship Committee.

Each candidate may only apply to one scholarship and will be notified of an award after their communication of admittance to the Programme.

ELIGIBILITY AND REQUESTED DOCUMENTATION

Its eligibility is always based not only on talent but also in the financial need of the candidate. Talent involves excellent academic performance as well as the impact of the candidate during the admission process. It will also be taken into account the diversity of the candidate profile (nationality, field of study, international exposure and career).

Financial need is taken into account through the analysis of the following economic documents that the candidate must submit in order to apply to a Need Based Scholarship:

- Last 2 pay-slips (Household incomes. An employer's letter signed and stamped stating the monthly or annual salary will also work).
- Bank statements of 2 previous months (All family members. A letter from the bank stating annual average balance also works).
- Tax report (Household incomes previous year).
- Specific Need based essay by which you may explain your current financial situation (You can find a second essay available at the back of this Scholarship Application Form. This will be required for the Scholarship Committee to better analyze the financial need).
- Financing Plan (Please explain how you plan to cover both tuition fees and living expenses during MSc Programme at ESADE Business School. Please provide an estimation of the Scholarship amount you expect to receive). You can find a template to be filled in at the end of this document.

IMPORTANT NOTE: Only documents in either English or Spanish language will be accepted by the Scholarship Committee. Sworn translation is not mandatory.

2. Select the Scholarship you would like to apply and complete your Scholarship Application Form
3. Send the ESADE Scholarship Application Form and all required documents in PDF format to the ESADE Financial Aid Office at financialaid@esade.edu

The ESADE MSc in Management Science Scholarships are awarded at the discretion of the Scholarship Committee. On average our Scholarship awards cover around 25% of Master tuition fees (50% is the maximum).
