## **Course Goals**

- · Explaining the links between state power, politics and economic tools
- · Assessing the role of maritime trade links and routes, foreign policy and infrastructures in regional and
- · Outlining the key interpretations, theories and approaches to contemporary world in terms of globalization and regionalization of economy

The student's background in the course "Geopolitics" will be a great addition to address "Geoeconomics", as many of the latter concepts are based on the former's.

## **Prerequisits**

No previous course is a must to enroll in "Geoeconomics".

## **Teaching methodology**

The teaching and learning dynamics gravitate around presential sessions, complemented with autonomous work. The last sessions of the course will include teamwork presentations by students. During the class sessions, student participation is encouraged. Every session is designed to foster participation through firechats, debates, opinions and other contributions.

Each session will require a complementary autonomous work in order to prepare specific topics that are part of the exam content. This will imply reviewing the session materials (slides) as well as selected articles and other resources (available via Moodle or recommended in class).

# Course contribution to program

Geoeconomics is a rising discipline that can be approached in at least three different ways:

- 1) the interplays between economic phenomena and geopolitics
- 2) the increasing economic tools that states are using to achieve its political objectives
- 3) how geography can be linked to economic imperatives and trends at national, regional and global levels

## **Short description**

This syllabus assesses the three approaches and provides insights and perspectives on how economic is becoming a defining tool of statecraft in an increasing globalized and interdependent world.

The scope and content of the topics includes: sea power, trade and the increasing competition among old and emerging powers for access, connectivity and infrastructures
