Course Goals

- · Learning how the control and management of natural resources helps to explain historical events and shape today's world politics and current geopolitical trends
- \cdot Assessing foreign policy, economic dynamics and corporate agendas in a context of growing competition for natural resources
- · Further develop academic background and train both analytical skills and critical thinking
- \cdot Linking concepts and theories from the past courses "Geopolitics" and "Geoeconomics" and linking them to the obtention, transportation and consumption of natural resources

Previous knowledge

The student's background in the courses "Geopolitics" and "Geoeconomics" is recommended.

Prerequisits

No previous course is a must to enroll.

Teaching methodology

The teaching and learning dynamics gravitate around presential sessions, complemented with autonomous work. The last sessions of the course will include teamwork presentations by students. During the class sessions, student participation is encouraged. Every session is designed to foster participation through firechats, debates, opinions and other contributions.

Each session will require a complementary autonomous work in order to prepare specific topics that are part of the exam content. This will imply reviewing the session materials (slides) as well as selected articles and other resources (available via Moodle or recommended in class).

Further code of counduct guidelines, recommendations and information about the teamwork presentations will be provided in the course's syllabus and in class.

Description

Course contribution to program

This course assesses how the discovery, access, transportation, management and consumption of natural resources has been (in history and nowadays) a source of economic, political and social power. It complements the previous courses of "Geopolitics" and "Geoeconomics".

Short description

Historical and present case studies will be discussed and analysed. Some examples include, among others, silk, gold, coffee, diamonds, oil, coltan, uranium and rare earths. The impact of the supply and demand of such commodities goes well beyond geopolitics and economy, as they also produce externalities at social level as well as the environment, which will also be considered. The syllabus will also pay special attention to the consequences of the invasion of Ukraine that started in 2022, the latest geopolitical confrontation in the Middle East and the ascending "Technological Cold War", including "Chip Wars".
