### Course Goals

After the course, students should be able to:

- explain the basic structures and dynamics of EU external relations;
- identify the various actors, instruments, and decision-making processes involved when analyzing cases or current affairs;
- critically analyze different policy areas of EU external action and how the roles of actors, competences, and rule-making evolve;
- have a clear overview of the EU's main fields of action and the policies it pursues in each.

### Previous knowledge

Previous knowledge about the institutional setup of the EU, about the role of international organizations and dynamics in international relations will be assumed.

### Prerequisites

All students from the programme are welcome. A good command of English is necessary.

Students are expected to have a basic knowledge of the EU and international relations based on previous courses.

Reading European and international news is a prerequisite for the course as we will discuss also current affairs.

### Teaching methodology

Class sessions will consist of lectures, debates (with the entire class and within smaller groups), problem analysis, case studies, group work and presentations. The sessions will be devoted to learning, challenging and applying the different aspects of EU external relations.

## Description

### Course contribution to program

The EU is a unique actor in international relations. It is one of the largest economic areas in the world and can be a highly influential player on the international stage. The EU's external competencies clearly reflect its distinctive characteristics: a constant tension between intergovernmental and supranational (community) methods of governance. This course is an introduction to EU External Relations.

We will begin with an overview of the internal dimension of the EU's external action: its sources, types, the main actors involved, the decision-making processes and instruments that shape EU external relations, as well as the role of international law within the EU and the guiding principles of its external action.

Please note:

Students can participate in the ordinary exam only if they have attended at least 80% of classes.  
The resit exam requires an attendance of at least 50% of classes.

Students need to achieve at least a grade of 5 points (out of 10) in the final exam in order to pass the course.

Students who have attended in-person less than 70% of classes (independently whether the missed classes are excused or unexcused), need to achieve at least a grade of 6 points (out of 10) in the resit exam to pass the course.

In case students cannot attend a class, they must inform Programme Direction and the professor by email in advance and provide the necessary justification (e.g. medical certificate). Accepted reasons for class absence include illness, major life events (e.g. births and deaths), ESADE activities for which the student has the written approval from the Programme Direction.

Other events that can be scheduled at another time (e.g. personal trips, job interviews, doctor's appointments etc.) will not be accepted as justified reasons of absence.

Late submissions of assignments will not be accepted after the deadline, unless an exception has been requested and granted before the deadline.

In case of unforeseen events that affect the teaching activities, the teaching schedule, the evaluation methods and percentages and the teaching guide may be modified to address the situation.
