### Course Goals

7. Assess case studies: Assess historical and contemporary case studies in international relations to identify and discuss the ethical challenges and dilemmas faced by policymakers and international actors.
8. Promote global justice: Explore concepts of global justice and their implications for international relations, including issues of equity, fairness, and the distribution of resources and opportunities.
9. Develop ethical leadership: Cultivate ethical leadership skills and an understanding of the importance of ethics in leadership roles within the context of international relations.

These objectives aim to equip students with the knowledge and skills necessary to navigate and address the ethical complexities and challenges

inherent in the field of international relations.

## Previous knowledge

No previous knowledge is needed to enroll in this course, beyond a general understanding of international issues and a basic grasp of current global events. ## Prerequisites

There are no strict prerequisites for enrolling in the course on ethics and international relations. However, it is recommended that students have:

1. General Knowledge: A basic understanding of international issues and current global events.
2. Interest in Global Affairs: A keen interest in global politics, international relations, and ethical questions.

This background will help students engage more deeply with the course material and participate effectively in discussions and debates.

## Teaching methodology

### 1. Weekly Assessments:

- Oral Examination: At the beginning of the course, students will be provided with three cultural materials (a movie, an article, and a book). The final exam will be a conversational evaluation where students discuss and analyze these materials in relation to the course content.
- Purpose: To assess students' ability to synthesize information from various sources, apply ethical theories to diverse cultural materials, and

engage in thoughtful dialogue.

Summary of Evaluation Components:

3. Final Exam (Conversational Analysis of Cultural Materials)
