Short description

The objective of this elective is to be able to analyse the relations between Mexico and the United States with a special emphasis on border dynamics. As a result of the North American Free Trade Agreement (NAFTA or USMCA), the social, cultural, political and economic dynamics in the North of Mexico have been consolidating and deepening

Today this region (1) has become key to understand the competitiveness of US value chains (2) both sides are intertwined and the region has developed its own dynamics in which a multitude of actors are involved (political, economic, cultural, criminal and the citizens)

The content will address all perspectives linked to the border between the two countries: political, social, economic and cultural.

At the end of the course, the student will be able to understand the complexity of this region that over the last decades has been attracting many of the most relevant actors of globalization
