### Teaching methodology

The subject combines theoretical knowledge with its practical implementation in the class activities.

During the sessions, the Lecturer will expose the program's contents using different learning methodologies and conduct group activities in which acquired knowledge will be put into practice.

Additionally, students must do group activities during the lecture sessions. One of the activities focuses on a role-play activity related to the World Trade Organization and a trade dispute. In terms of tasks, students must prepare these consist of:

Finally, we recommend that students dedicate some hours of personal work to this subject during the week to consolidate acquired knowledge of each topic. This personal work will consist of reviewing concepts, ideas, and theoretical aspects given in class and complementing them with the readings. It would be helpful to prepare and do the activities that will be evaluated.

## Description

### Course contribution to program

The objective of the subject "The Influence of International Economic Organizations in the New Order" is to address the study of the international economy from the perspective of its institutional organization and the main international economic organizations that conform it, and to what extent those organizations influence in the actions, decisions, and behavior of the countries within the international economic system.
