Title: "Understanding the Affects of Culture on Corrupt Organizations: An International Study". The purpose of my dissertation is to examine how individuals use various types of power to recruit coworkers and others to participate in unethical acts. Specifically, I examine how power is influenced by culture. I am currently performing experimental research where I test MBA students – based upon cultural background – to determine which of the five types of power (based upon the French and Raven taxonomy of power) is the most powerful influence when recruiting individuals to participate in unethical acts. This research is being conducted in both Spain and the United States. The theoretical section of my dissertation is currently under "revise and resubmit" status at the *Journal of Business Ethics*. The dissertation will be completed in June 2008.

The dissertation proposal was presented at the doctoral consortium of the 2007 Academy of International Business (AIB) conference held in Indianapolis, Indiana as well as the doctoral consortium of the 2007 European Academy for Business in Society (EABIS) held at IESE Business School in Barcelona, Spain.
